INSTRUCTIONS FOR USE

Spray directly on fabrics, curtains, sofas, carpets and linen. It can be also used for car interior fabrics. Perfume and regenerate eliminating unpleasant odours.

LAUNDRY PERFUME - BLU WASH

Instructions for use: Washing Machine: From 4 to 6 pressures on the dispenser, depending on the desired intensity of the perfume, into the fabric softener dispenser drawer. **Hand washing:** From 4 to 6 pressures on the dispenser into 5 liters of water for the final rinse. **Warnings:** If spilled it may cause damage to surfaces, in such a case clean immediately.
